

Avery Road & Rings Road/Cara Road Intersection Improvement Project

Dear Dublin resident

The City of Dublin is committed to improving the quality and safety of our roadway and utility infrastructure for our residents. The Capital Improvements Program (CIP) identified the construction of a new roundabout at the intersection of Avery Road and Rings Road/Cara Road. The project also includes water main and sanitary sewer utility extensions in the project area. This flyer is to notify you and to help prepare you for the construction of this project. Attached you will find a project exhibit showing what the project will look like after construction. You can also check for updates on the project webpage at:

During the process, you can expect the following:

- Relocation of existing private utilities in conflict with new roadway infrastructure.
- Construction of new sanitary sewer lines.
- Installation of new stormwater facilities including pipe, structures and a retention pond.
- Installation of new waterlines and hydrants.
- Installation of new sidewalk and shared use path facilities including a pedestrian bridge.
- Construction of a new roundabout at Avery Road and Rings Road/Cara Road intersection.
- Construction of new intersection lighting and updated traffic signage.

Ultimately, this intersection improvement is intended to improve safety for area residents and the traveling public while providing vital City utility infrastructure to Dublin residents.

Your patience and cooperation during the project is appreciated. The City and our contractor, Strawser Paving Company, will make every effort to reduce disruptions while working to complete this project in a professional and timely manner.

When will work take place?

Material delivery and staging for the project will be begin the week of February 3rd. Construction is scheduled to start on February 10th to install sanitary sewer lines and manholes. The project is expected to be completed by October 2025.

Message boards will be placed along the roadways the week of February 3rd to notify and inform motorists of the start date for traffic impacts.

Typical construction work hours will be Monday through Saturday, 7:00 A.M. to 6:00 P.M. daily.

Traffic impacts and construction phasing

There are four major phases of construction for this project with anticipated traffic impacts. Here is a summation of these phases for your reference:

1. Installation of sanitary and storm sewer. Construct pedestrian bridge abutments.
 - A closure of Rings Road East of Avery Road with detour during work hours for up to 5 days
2. Install Stormwater and Water system components on Rings Road west of Avery Road and on Cara Road and Cara Court.
 - Rings Road west of Avery Road will be closed for 135 days with detour
 - Access will be maintained to homes and Ted Kaltenbach Park
 - Cara Road and Cara Court construction will begin during this phase of work, including a temporary access road to Avery Road
3. Completion of the roundabout.
 - Rings Road and Avery Road closure for 45 days with detour
 - Access will be maintained to homes and Ted Kaltenbach Park
4. Completion of Avery Road
 - Re-open Rings Road and Avery Road
 - Open the roundabout and perform the remaining project work

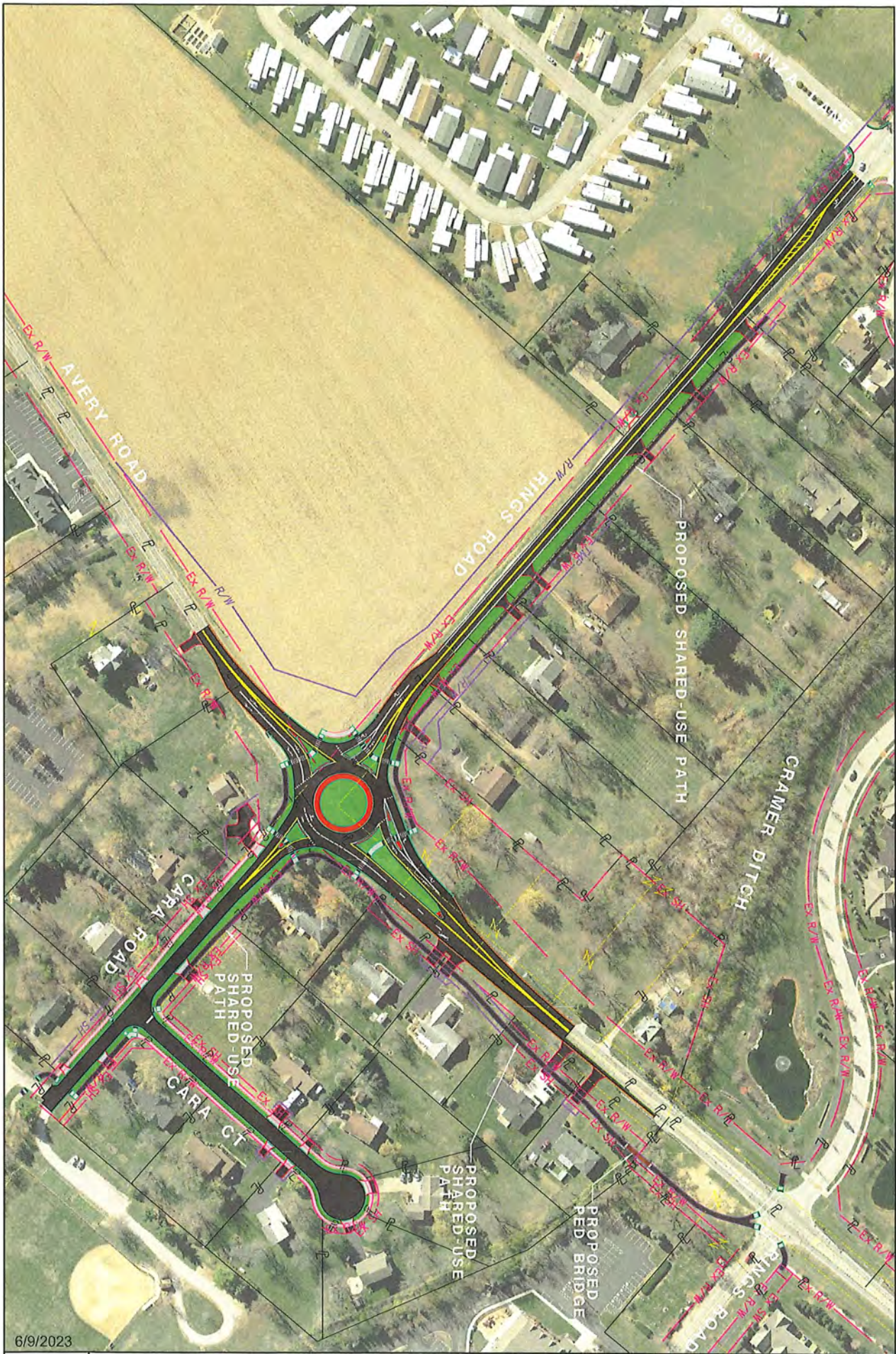
